AMENDMENT TO MASTER DEED

THIS AMENDMENT made and executed in Blount County,  
Tennessee, this 15<sup>th</sup> day of May, 1987, by TURNBERRY, INC.

WITNESSETH:

THAT WHEREAS, Turnberry, Inc., has heretofore executed  
and dedicated a Master Deed of record in the Register's Office  
for Blount County, Tennessee, in Book of Warranty Deeds 475,  
page 324; and

WHEREAS, Turnberry, Inc., is desirous of amending  
Exhibit A and Exhibit B of said Master Deed.

NOW, THEREFORE, FOR AND IN CONSIDERATION of the  
premises and other good and valuable considerations, Exhibit A  
to the Master Deed of record in Book of Warranty Deeds 475,  
page 324, is hereby amended by adding the following description:

SITUATED, LYING AND BEING in the 19th Civil  
District of Blount County, Tennessee, and  
being more particularly described as  
follows:

BEGINNING at an iron pin in northern edge  
of Jamestown Way corner to Care Inn; thence  
N 76-43-40 W, 112.13 feet to an iron pin;  
thence with a curve to the right, having a  
radius of 20 feet, an arc distance of 31.29  
feet, a chord bearing of N 31-54-40 W, 28.19  
feet to a point at the edge of Claremont  
Drive, N 12-54-15 E, 193.47 feet to a point  
at the edge of Claremont Drive; thence with  
a curve to the right having a radius of 75  
feet, an arc distance of 35.91 feet, a chord  
bearing of N 26-37-10 E, 35.56 feet to a  
point at the edge of Claremont Drive; thence  
with Claremont Drive, N 40-20-00 E, 46.66  
feet to a point at the edge of Claremont  
Drive; thence S 49-39-55 E, 115.01 feet to  
a point, corner to Care Inn; thence with  
Care Inn, S 12-54-15 W, 237.18 feet to the  
point of BEGINNING.

Schedule B is hereby amended by adding the following:

Building 15	1,672 square feet
Building 16	1,672 square feet

Building 17 1,672 square feet  
Building 18 1,364 square feet  
Building 13 is corrected to show 1,364 square feet.


